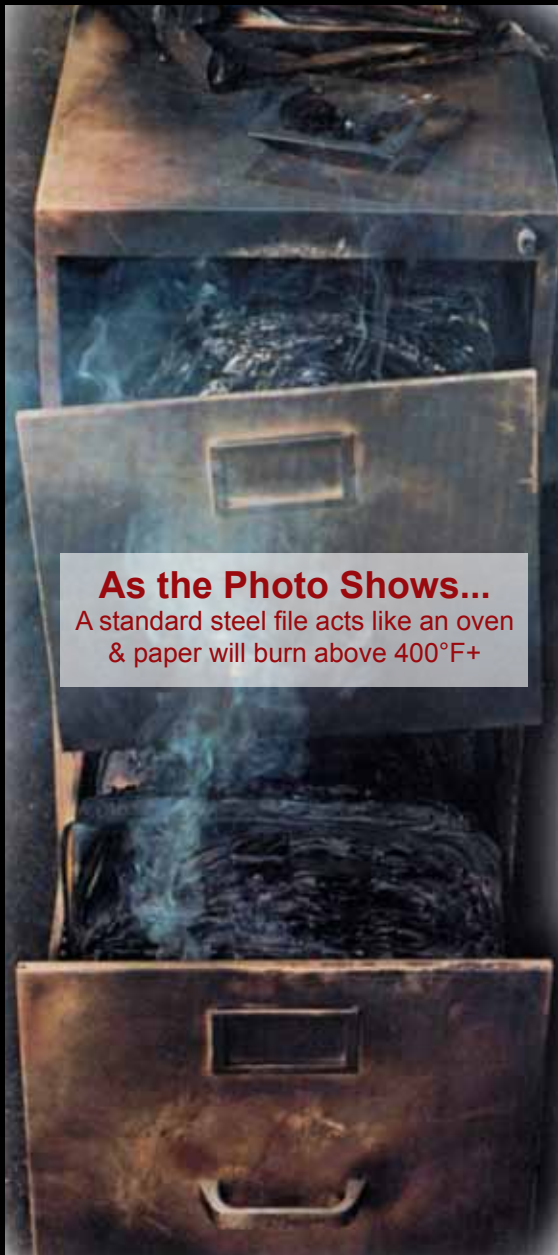

## File Features

**FIREPROOF INSULATION**  
*is 100% gypsum, reinforced by a 1" X 2" lattice made of 14-gauge, galvanized welded-steel wire, providing peace of mind from fire, impact or explosion.*

**FINISH**  
*an attractive but durable electrostatic powder coat finish applied to all sides, including the bottom.*

**DRAWER BODIES**  
*are built with high sides for use with hanging folders-no additional frames are required. 31" deep vertical files also include sliding drawer dividers for drop file use.*

**DRAWER SUSPENSIONS**  
*are maintenance-free*



**MEDECO® SECURITY LOCK**  
**Provides Restricted Duplication**  
*Locks are keyed randomly or in groups if requested.*

**DRAWER PULLS**  
*are surface-mounted to allow for extra insulation inside drawer heads.*

- The baked-dry gypsum insulated cast removes free-moisture and protects records from dampness and mildew present in unbaked casts.

## Protect Vital Paper Documents

- Lateral 2, 3, 4 Drawer
- Same Quality features as the above vertical file information, *except*, no sliding drawer dividers
- Drawers are designed for hanging folders.  
**Legal side-to-side**, or **Letter 3 rows front to back**
- Capacity: **Each drawer** has 38" of legal filing (side-to-side) or 45" of letter filing (3 rows x 15" front-to-back).
